**INTELLECTUAL PROPERTY SECURITY AGREEMENT  
RELEASE**

This Intellectual Property Security Agreement Release ("Release") is effective as of September 19, 2013 by and between LABMORGAN INVESTMENT CORPORATION ("Security Agent") and REARDEN COMMERCE, INC., a California corporation, ("Grantor") (collectively the "Parties").

**RECITALS**

Security Agent and Grantor entered intellectual property security agreements effective as of September 17, 2009 and recorded them with the United States Patent and Trademark Office on September 21, 2009 at Reel/Frame No. 023254/0243 (patents) and Reel/Frame No. 4064/0945 (trademarks) ("2009 Security Agreements"). Security Agent and Grantor entered an Intellectual Property Security Agreement Release Confirmation dated April 13, 2012 and recorded it with the United States Patent and Trademark Office on April 16, 2012 at Reel/Frame 028053/0769 (patents) and on April 17, 2012 at Reel/Frame No. 4758/0822 (trademarks) (together, "2012 Release"). The 2012 Release released Security Agent's liens and security interests in Grantor's intellectual property under the 2009 Security Agreements. One patent application, U.S. 11/768,882 published as 20090006142, and one trademark application, Serial No. 76661266, listed in the 2009 Security Agreements were inadvertently excluded from the 2012 Release.

Pursuant to the terms of a Term Loan and Security Agreement dated May 25, 2012 as amended and restated by the Amended and Restated Term Loan and Security Agreement dated October 26, 2012, as further amended to date (the "Term Loan Agreement"), Security Agent and Grantor entered a Grant of Security Interest in Intellectual Property Rights effective as of September 7, 2012 and recorded it with the United States Patent and Trademark Office on November 7, 2012 at Reel/Frame No. 029259/0491 (patents) and Reel/Frame No. 4895/0916 (trademarks) ("2012 Security Agreement"). The term "Intellectual Property Collateral," as used herein, shall mean all of Grantor's patent and trademark registrations and applications: referenced in the 2009 Security Agreements and the 2012 Security Agreement (including each of these agreements' appendices); listed in Schedule A of this Release; and/or recorded at the United States Patent and Trademark Office at Reel/Frame No. 029259/0491 (patents), Reel/Frame No. 023254/0243 (patents), Reel/Frame No. 4895/0916 (trademarks), and Reel/Frame No. 4064/0945 (trademarks). This Release confirms that Grantor has satisfied all terms to secure release of all of Security Agent's liens and security interests in the Intellectual Property Collateral under both the 2009 Security Agreements and the 2012 Security Agreement.

NOW, THEREFORE, Security Agent agrees as follows:

**RELEASE**


Security Agent, on behalf of itself in relation to the 2009 Security Agreements and on behalf of the Lenders (as such term is defined in the Term Loan Agreement) in relation to the 2012 Security Agreement, hereby releases all liens and security interests in the Intellectual Property Collateral.
