Pursuant to Title 8, Section 251 of the Delaware General Corporation Law, the undersigned corporations hereby certify in connection with the merger of Fugro Robertson Inc., a Delaware corporation ("Merger Corporation"), with and into CGGVeritas Services (U.S.) Inc., a Delaware corporation ("CGGVeritas"), as follows:

FIRST: The name and state of incorporation of each of the constituent corporations to the merger is (a) CGGVeritas Services (U.S.) Inc., a Delaware corporation, and (b) Fugro Robertson Inc., a Delaware corporation.

SECOND: An agreement and plan of merger (the "Merger Agreement") has been approved, adopted, executed and acknowledged by each of Merger Corporation and CGGVeritas in accordance with Title 8, Section 251 of the General Corporation Law of the State of Delaware.

THIRD: Upon the terms of the Merger Agreement, Merger Corporation will merge with and into CGGVeritas with CGGVeritas being the surviving entity. The name of the surviving corporation is CGGVeritas Services (U.S.) Inc., a Delaware corporation (the "Surviving Corporation").

FOURTH: The Certificate of Incorporation of CGGVeritas prior to the effective date shall be the Certificate of Incorporation of the Surviving Corporation.

FIFTH: The executed Merger Agreement is on file at 10300 Town Park Drive, Houston, Texas 77072, an office of the Surviving Corporation.


SIXTH: A copy of the Merger Agreement will be furnished by the Surviving Corporation on request, without cost, to any stockholder of either constituent corporation.

SEVENTH: The Merger shall become effective on April 1, 2013.


