RELEASE OF SECURITY INTEREST

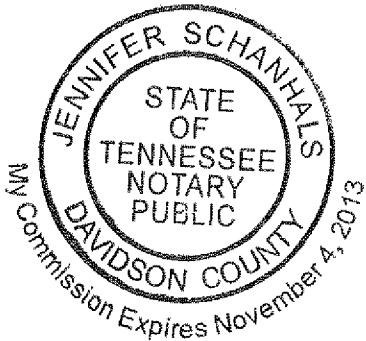
