## TRADEMARK AGREEMENT

3. Accordingly, ASSIGNOR has assigned and does hereby assign all right, title and interest in and to the Trademark, together with the goodwill of the business symbolized by and associated with the Trademark.
4. Except as corrected by this Agreement and the Previous Corrective Agreement, the undersigned hereby ratifies, confirms and republishes the Existing Agreement.
