**TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARKS**  
("Release"), dated as of the 26<sup>th</sup> day of September 2013, by **WELLS FARGO BANK,  
NATIONAL ASSOCIATION**, ("WF"), having an office at 120 Mountain View Blvd. #200,  
Basking Ridge, NJ 07920, and **ARGIT INTERNATIONAL MARKETING, INC.**, a New  
Jersey corporation ("AIM"), having its principal executive offices at 40 New Dutch Lane,  
Fairfield, NJ 07074.

**WITNESSETH:**

**WHEREAS**, pursuant to the parties' July 6, 2010 Security Agreement ("Security Agreement"), AIM granted to WF Security Interests ("Security Interests") in certain collateral as defined in said Security Agreement, including the U.S. trademark registrations listed in Exhibit A ("Trademarks") hereto:

**WHEREAS**, the Security Interests were recorded in the United States Patent and Trademark Office at reel/frame 4244/0839; and

**WHEREAS**, WF and AIM have agreed to retire the parties' obligations under the Security Agreements and WF wishes to release its Security Interests in the U.S. trademark registrations listed in Exhibit A hereto;

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. WF hereby releases its Security Interests and any right, title and interest which it may have in and to all Trademarks listed on Exhibit A hereto, does hereby release and terminate all liens and security interests in and to the Trademark

collateral which were granted, pledged and assigned to WF, including the right to sue for past, present and future infringements thereof.

2. The parties hereto agree that at any time and from time to time, upon the reasonable written request of another party hereto, such party will promptly execute and deliver all further instruments and documents, and take all further action, that may be necessary, or reasonably desirable, or that such other party may reasonably request, in order to effect the purposes of this Release.

3. This Release may be filed by WF or AIM with the United States Patent and Trademark Office without further notice.
