

In accordance with the provisions of the Arizona Corporation Business Act §10-1107, the undersigned business entities hereby submit the following Articles of Merger:

1. **Parties to the Merger.** The names of the business entities that are parties to the merger are Genz Benz Enclosures, Inc., an Arizona corporation (the "Merging Corporation") and KMC Music, Inc., a Connecticut corporation (the "Surviving Corporation") (the "Merger").

2. **Surviving Corporation.** The name of the Surviving Corporation is KMC Music, Inc., a Connecticut corporation, and its address in the jurisdiction in which it is domiciled is 20 Old Windsor Road, Bloomfield, CT 06002.

3. **Irrevocable Appointment.** The Surviving Corporation irrevocably appoints the Arizona Corporation Commission as its agent to accept service of process in a proceeding to enforce any obligation or the rights of dissenting shareholders of each domestic corporation that is a party to the Merger. The Arizona Corporation Commission shall mail any such process to the Surviving Corporation at 20 Old Windsor Road, Bloomfield, CT 06002.

4. **Amendments.** The Certificate of Formation of the Surviving Corporation will not be amended by the Merger.

5. **Effective Date of the Merger.** The Merger shall be effective at 11:59 p.m. Eastern Standard Time on December 28, 2008.




