**DECLARATION OF REX W. MILLER, II**

1. I, Rex W. Miller, II, am counsel for Asia Fastening (U.S.) Inc. and authorized to submit this Declaration.
2. On August 3, 2010, a Security Agreement between Asia Fastening (U.S.) Inc. and Bank of America, N.A. was recorded with the U.S. Patent and Trademark Office at Reel/Frame 4263/0271.
3. The Security Agreement contains a typographical error in the registration number for the mark RAPIDSET; RAPIDSET was incorrectly designated as Registration Number 2,852,044, when its correct registration number is Reg. No. 2,862,044.
4. Registration No. 2,862,044 for the mark RAPIDSET is owned by Asia Fastening (U.S.) Inc., party to the Security Agreement. This RAPIDSET registration is the proper subject of the recorded Security Agreement.
5. As a result of the typographical error, the Security Agreement was erroneously recorded in connection with U.S. Trademark Registration No. 2,852,044 for the mark AQUARIONLINE.
6. Asia Fastening (U.S.) Inc. is not the owner of the mark AQUARIONLINE or Registration No. 2,852,044. As such Reg. No. 2,852,044 (AQUARIONLINE) is not the subject of the recorded Security Interest between Asia Fastening (U.S.) Inc. and Bank of America, N.A.
