TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS
(this "Release"), dated as of September 30, 2013 by Madison Capital Funding, LLC, as agent, (the "Agent") in favor of Integrated Supply Network, LLC, a Florida limited liability company ("ISN") and K-Tool Corporation of Michigan, a Michigan corporation ("K-Tool", and together with ISN, the "Companies").

WHEREAS, pursuant to the terms of that certain: (i) Trademark Security Agreement dated as of July 8, 2011 by and between ISN and the Agent as filed with the Assignment Division of the United States Patent and Trademark Office (the "USPTO") on July 13, 2011 at Reel 004581, Frame 0869; and (ii) Trademark Security Agreement dated as of December 11, 2012 by and between the Companies and the Agent as filed with the Assignment Division of the USPTO on December 11, 2012 at Reel 004916, Frame 0863 (collectively, the "Security Agreements"), the Companies granted to the Agent a security interest in and lien on all of their Trademark Collateral (as defined in the Security Agreements), including, without limitation, the trademarks identified on Schedule A attached hereto; and

WHEREAS, the Companies have requested that the Agent release the security interests liens granted to it in the Trademark Collateral; and

WHEREAS, the Agent wishes to release the security interest in and lien on the all of the Trademark Collateral, including, without limitation, the trademarks identified on Schedule A attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent states as follows:

The Agent hereby terminates and releases its security interest in and first priority lien on the Trademark Collateral, and the Agent hereby assigns and transfers to the Companies, without recourse, all of its right, title and interest in and to the Trademark Collateral, including, without limitation, each of the trademarks identified on Schedule A attached hereto, effective as of the date set forth above.

The Agent understands and agrees that this Release may be recorded by or for the Company with the USPTO or any similar office or agency within or outside the United States.
