THE TAKAYAMA FAMILY TRUST DATED JULY 1, 1992
AS AMENDED AND RESTATED ON OCTOBER 9, 2008

ARTICLE ONE
CREATION OF TRUST

1.1. Preamble. DONALD M. TAKAYAMA and DIANE L. TAKAYAMA, husband and wife, both of San Diego County, California, are the settlors of THE TAKAYAMA FAMILY TRUST DATED JULY 1, 1992, created under that certain Declaration of Trust dated that same date. DONALD M. TAKAYAMA and DIANE L. TAKAYAMA are the co-trustees duly appointed and acting under and by terms of that Declaration of Trust. ("Trust" or "Declaration of Trust"). On July 31, 2000, the settlors executed an amended and restated Declaration of Trust. In Article Ten, Sections A and B of that amended and restated Declaration of Trust, which sections are incorporated herein by reference, the settlors reserved the right, during their joint lifetimes, to revoke or amend the Declaration of Trust, in whole or in part, by an instrument in writing. The settlors now wish to further exercise their right of amendment and, to that end, do hereby amend that Declaration of Trust in the terms set forth in this amended and restated Declaration of Trust. The trustees hereby consent to the terms of this amended and restated Declaration of Trust. The parties agree that upon execution of this instrument, the prior Declaration of Trust, as amended and restated on July 31, 2000, shall be replaced in whole, and the terms of this amended and restated Declaration of Trust shall supersede the terms of the prior Declaration of Trust as previously amended in its entirety for all purposes. The settlors and the trustees confirm that all assets currently titled in the name of THE TAKAYAMA FAMILY TRUST DATED JULY 1, 1992, shall continue to be held by the trustees as trust assets of this amended and restated Declaration of Trust.

1.2. Names of Trusts. The trusts created by this instrument shall be known collectively as THE TAKAYAMA FAMILY TRUST DATED JULY 1, 1992, AS AMENDED AND RESTATED ON OCTOBER 9, 2008, and each separate trust created under this instrument shall be referred to by adding the name or designation of that separate trust as it appears in the appropriate section of this instrument.

1.3. Effective Date. This declaration shall be effective immediately on

Designated Ancestor in the manner described in this section as if the deceased member were the Designated Ancestor as to that share.

8.13. Gifts to "Heirs". For any gift to heirs of either or both settlors that is made in this instrument, those heirs shall be determined as if the settlor or settlors had died intestate at the time for distribution prescribed in this instrument, and the identity and shares of those heirs shall be determined according to the California laws of succession that are in effect at the time the settlor or settlors are deemed to have died.


SIGNATURE AND EXECUTION

DECLARATION OF INTENT REGARDING SCHEDULES OF ASSETS

We understand that we are responsible for ensuring that all of our assets are properly transferred into the Trust. As Co-Trustees, we accept this transfer and agree as above.
