**TRADEMARK AND SERVICE MARK ASSIGNMENT AGREEMENT**

- Parties; Effective Date.** This Trademark Assignment Agreement ("Agreement") is between Comerica Incorporated, a Delaware corporation, qualified as a Michigan corporation, with an address of MC-6506, 1717 Main St., Dallas, Texas 75201 ("Assignor"), and Comerica Bank, a Texas banking association, with an address of MC-6506, 1717 Main St., Dallas, Texas 75201 ("Assignee"). This Agreement is effective on October 1, 2013.
- Purpose of Agreement.** Assignor is the owner of the trademarks described in Exhibit A attached thereto (the "Marks"). Assignor seeks to assign the Marks to Assignee, and Assignee seeks to acquire the Marks from Assignor, along with the business to which the Marks pertain and the goodwill associated with the Marks, pursuant to the terms of this Agreement.
- Assignment of Marks.** For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns, sells, transfers, and conveys all right, title and interest in and to the Marks, including, without limitation: (a) all goodwill associated with the Marks, and all goodwill associated with the goods and/or services to which the Marks pertain; (b) all trademark and service mark registrations, and pending applications for registration, of the Marks, and any renewals thereof; (c) the right to sue or otherwise recover for any and all past, present and future infringements and misappropriations of the Marks; (d) all income, royalties, damages and other payments now and hereafter due and/or payable with respect to the Marks; and (e) any and all other rights, whether statutory or common law, corresponding thereto and all other rights of any kind whatsoever accruing thereunder, together in each case with the goodwill of the business connected with the use of, and symbolized by, the Marks.
- Cooperation.** Assignor agrees to provide, at Assignee's cost, whatever assistance is reasonably required by Assignee to perfect, secure, enforce or otherwise maintain its interests in the Marks.
- Binding Effect.** This Agreement shall be binding upon and inure to the benefit of the parties' heirs, representatives, successors, and assigns.
