TRADEMARK SECURITY AGREEMENT

THIS TRADEMARK SECURITY AGREEMENT is made this 1st day of October, 2013, between TRISTAR PETROSERV, INC., a Texas corporation, having a place of business at 12600 N. Featherwood Drive, Suite 330, Houston, Texas 77034 ("Grantor") and TEXAS CAPITAL BANK, NATIONAL ASSOCIATION, a national banking association, having a place of business at One Riverway, Suite 2100, Houston, Texas 77056 ("Lender").

WHEREAS, Grantor owns the Trademarks and Trademark Applications (herein so called) listed on Schedule A attached hereto, as the same may be amended from time to time;

WHEREAS, TRISTAR GLOBAL ENERGY SOLUTIONS, INC., a Texas corporation ("~~Borrower~~"), and Lender have entered into that certain Credit Agreement dated as of October, 2013, as the same may hereafter be amended, restated, modified or supplemented from time to time (the "Credit Agreement");

WHEREAS, pursuant to the terms of the Security Agreement dated as of October, 2013, among Grantor, Borrower, Global Vapor Control, Inc., a Texas corporation, United Laboratories International, LLC, a Delaware limited liability company, and Lender (the "Security Agreement"), Grantor has granted to Lender a security interest in all of the Trademarks and Trademark Applications owned or at any time hereafter acquired by Grantor or in which Grantor now has or at any time in the future may acquire any right, title, or interest in or to, as collateral to secure the Secured Obligations (as defined in the Security Agreement);

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the parties hereby agree as follows:

1. Grantor does hereby grant to Lender a security interest in the following property, wherever arising or located (the "Trademark Collateral"): all of Grantor's right, title and interest in and to the Trademarks and Trademark Applications now owned or at any time hereafter acquired by Grantor or in which Grantor now has or at any time in the future may acquire any right, title, interest or license to, including all proceeds and products of any and all of the foregoing.
2. Grantor does hereby further acknowledge and affirm that the rights and remedies of Lender with respect to its security interests in the Trademark Collateral made and granted herein are more fully set forth in the Credit Agreement and the Security Agreement, the terms and provisions of which are incorporated by reference herein.

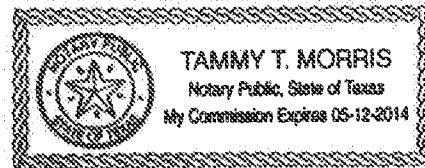
