TRADEMARK SECURITY AGREEMENT RELEASE.

This TRADEMARK SECURITY AGREEMENT RELEASE (the "Release") dated September 30, 2013, is made by Bank of America, N.A., as administrative agent (together with any successor collateral agent appointed pursuant to the Credit Agreement, the "Administrative Agent") for the Secured Parties in favor of IRI Group Holdings, Inc., a Delaware corporation, IRI Holdings Inc. as successor in interest to Blackcomb Acquisition, Inc., a Delaware corporation, IRI Holdings Inc., a Delaware corporation and each Subsidiary of Borrower listed on Schedule A thereto (collectively, the "Grantors"). All capitalized terms used herein and not otherwise defined shall have the meaning assigned to such terms in that certain Guarantee and Collateral Agreement, dated June 1, 2011, among Holdings, the Borrower, the Subsidiaries of the Borrower (as identified therein) and the Administrative Agent (the "Security Agreement").

WHEREAS, certain Grantors entered into that certain Credit Agreement dated as of June 1, 2011 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Credit Agreement") among Holdings, the Borrower, the Lenders party thereto and the Administrative Agent;

WHEREAS, pursuant to the Credit Agreement and the Security Agreement, certain Grantors entered into that certain Trademark Security Agreement, dated as of June 1, 2011 (as amended, amended and restated, supplemented, or otherwise modified from time to time, the "Trademark Security Agreement"), under which the Grantors granted to the Administrative Agent for the ratable benefit of the Secured Parties a security interest in and to certain intellectual property of the Grantors;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on June 9, 2011 at Reel 004557 and Frame 0581; and

WHEREAS the Administrative Agent now desires to release its security interest in and to the Collateral (as defined below).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby agrees as follows:

SECTION 1. Release of Grant of Security. The Administrative Agent hereby releases to each Grantor its security interest in all of such Grantor's right, title or interest in or to the following (the "Trademark Collateral"):

(i) all trademarks, service marks, trade names, corporate names, company names, business names, fictitious business names, trade styles, trade dress, logos, other source or business identifiers, designs and general intangibles of like nature, now existing or hereafter adopted or acquired, all registrations and recordings thereof, and all registration and recording applications filled in connection therewith, including registrations and registration applications in the United States Patent and Trademark Office or any similar offices in any State of the United States or any other country or any

- (ii) all Contractual Obligations providing for the grant of any right to or under any Trademarks, including those listed on Schedule A; and
 - (iii) all goodwill associated with or symbolized by the Trademarks.
- SECTION 2. <u>Recordation</u>. The Administrative Agent authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this Release.
- SECTION 3. Governing Law. This Release shall be governed by, and construed in accordance with, the laws of the State of New York.
- SECTION 4. <u>Purpose</u>. This Release has been executed and delivered by the Administrative Agent for the purpose of terminating, releasing, removing, or otherwise eliminating the security interest of the Administrative Agent with respect to the Trademark Collateral.
- SECTION 5. <u>Miscellaneous</u> This Release: (i) shall be binding upon the Grantee's legal representatives, successors, and assigns, and (ii) may be executed in several parts, each of which shall be an original and all of which taken together shall constitute one and the same agreement.
