TRADEMARK ASSIGNMENT

This Trademark Assignment (hereinafter referred to as "Assignment") is effective as of the 4th day of Sept, 2013 by and between Alan Ceppos and Frederic Rambaud, individuals, having an address of 153 Little Noyack Path, Water Mill NY 11976 (hereinafter referred to as "ASSIGNORS"), and Lena Irene Hirzel and Jacques Henri Francois Guillemet, individuals, having an address of 59 rue de Turenne F075003 Paris, France (hereinafter referred to as "ASSIGNEES").

WHEREAS, ASSIGNORS have claimed rights to the trademark PYLONES ("Mark") and registered a trademark encompassing PYLONE, Registration No. 3200271 ("Registration") and wish to transfer said trademark, trademark rights and goodwill and any and all registrations for the Mark PYLONES to ASSIGNEES.

WHEREAS, ASSIGNEES are desirous of acquiring all rights, title, and interest in and to the Mark and Registration worldwide; and

WHEREAS, ASSIGNORS are willing to assign to ASSIGNEES, all rights, title, and interest in and to the Mark and Registration worldwide.

NOW, THEREFORE, for good and adequate consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

A. ASSIGNORS do hereby assign, sell and transfer to ASSIGNEES, ASSIGNEES' successors and assigns, all worldwide rights, title, and interest in and to the Registration and the Mark shown in said Registration, including all common law rights, federal rights, including those associated with the Mark and Registration, including trade name rights, and the goodwill of the business or portion thereof, to which the Mark pertains, and the right of ASSIGNORS to conduct business under said Mark.

B. ASSIGNORS warrant that they have no other trademarks, registrations or pending applications, other than the Registration, which contain the word PYLONE anywhere in the world.

C. ASSIGNORS further assign to ASSIGNEES the right to sue for past infringement and to recover and hold all damages and profits arising from the Mark or Registration.

D. ASSIGNORS shall not attempt to register hereinafter any corporate name, trademark and/or domain name incorporating the Mark or any phonetic variants thereof.

E. ASSIGNEES have paid good and valuable consideration for this assignment receipt of which is hereby acknowledged.

F. ASSIGNORS warrant that there are no licenses, encumbrances, or other agreements, either written, oral or implied, relating to the aforementioned Mark or Registration.

G. ASSIGNORS warrant that it is not aware of any third party litigation, dispute or potential dispute regarding the Mark or Registration.

ASSIGNORS further warrant that, upon the request of ASSIGNEES, they will execute all papers, make all rightful oaths, testify on behalf of ASSIGNEES, furnish such documents, materials, information and/or assistance at the expense of ASSIGNEES, and do all other lawful acts necessary to perfect the assignment of the Mark and Registration to ASSIGNEES and otherwise carry out the intent of this Agreement.

I. This Assignment shall be binding upon ASSIGNORS, ASSIGNORS' successors and assigns, and upon all others acting by, through, with or under ASSIGNORS' direction or control, and all those in privity therewith.

J. This Assignment constitutes the entire agreement between the parties into which all prior agreements and negotiations are incorporated herein, and it supercedes any prior agreements.
