TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of September 30, 2013, by NXT Capital LLC, in its capacity as agent (in such capacity, the "Agent") for certain financial institutions (collectively, the "Lenders"). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Assignment (as defined below).

W I T N E S S E T H:

WHEREAS, ROM Acquisition Corporation, a Delaware corporation (the "Grantor") and Agent are parties to a Trademark Security Agreement dated as of March 30, 2012 (as amended, restated, supplemented or otherwise modified from time to time, the "Assignment"), pursuant to which Grantor granted a security interest to Agent in certain trademarks ("Trademarks") and Trademark Rights (as defined below) as security for certain obligations owing by Grantor to Agent and the Lenders, including the Trademarks set forth on Schedule 1 hereto; and

WHEREAS, the Assignment was recorded by the Trademark Division of the United States Patent and Trademark Office on April 2, 2012, at Reel 4749, Frame 0883; and

WHEREAS, Grantor has requested that Agent release its security interest in the Trademarks and Trademark Rights and reassign the same to the Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases its security interest in all of Grantor's right, title and interest in and to the U.S., state and foreign trademarks, trademark registrations and trademark applications, set forth on Schedule 1 attached hereto and all goodwill associated with the foregoing (collectively the "Trademark Rights").

2. Agent hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Agent, all of Agent's right, title and interest in and to the Trademarks and the Trademark Rights.
