ARTICLES OF AMENDMENT AND RESTATEMENT

VISUAL ANALYTICS INCORPORATED, a Maryland close corporation (hereinafter referred to as the "Corporation"), having its principal office in the State of Maryland in Frederick County, Maryland, hereby certifies to the State Department of Assessments and Taxation of Maryland that the Corporation desires to amend and restate its charter. As approved by the directors and shareholders of the Corporation, the charter of the Corporation is hereby amended and restated in its entirety to read as follows:

FIRST: The name of the Corporation is

Raytheon Visual Analytics Incorporated

SECOND: The purpose for which the Corporation is formed is to engage in any lawful business or other activities permitted by a corporation organized under the General Laws of the State of Maryland. The foregoing purpose shall be in no way limited or restricted by reference to, or inference from, the terms of any other clause of this or any other Article of the Charter (as defined in Section 1-101 of the Annotated Code of Maryland, Corporations and Associations Articles) of the Corporation and is intended to be and shall be construed as powers as well as purposes of the Corporation.

THIRD: The street address of the principal office of the Corporation in Maryland is 50 Citizens Way, Suite 202, Frederick, Maryland 21701.

FOURTH: The name of the resident agent of the Corporation in Maryland is The Corporation Trust Incorporated, whose address is 351 West Camden Street, Baltimore, Maryland 21201. Said resident agent is a Maryland corporation.

FIFTH: The total number of shares of capital stock which the Corporation has authority to issue is one hundred thousand (100,000) shares of common stock with a par value of \$1.00 per share, with the par value amounting in the aggregate to One Hundred Thousand Dollars (\$100,000). A majority of the entire Board of Directors, without action by the shareholders, may amend the Charter to increase or decrease the aggregate number of shares of capital stock or the number of shares of capital stock of any class that the Corporation has authority to issue. The Board of Directors is hereby empowered to authorize the issuance from time to time of shares of its capital stock of any class, whether now or hereafter authorized, or securities convertible into shares of its capital stock of any class or classes, whether now or hereafter authorized, for such consideration as may be deemed advisable by the Board of Directors and without any action by the shareholders.

SIXTH: The number of directors of the Corporation shall be fixed at one, which number may be increased or decreased pursuant to the By-Laws of the Corporation, but shall never be less than the minimum number permitted by the General Corporation Law of Maryland now or hereafter in force. The sole director, who shall serve until the next annual meeting of shareholders or until his successor is duly elected and qualified, is Dana Ng.

IN WITNESS WHEREOF, the Corporation has caused these Articles of Amendment and Restatement to be signed in its name and on its behalf by its President and attested by its Assistant Secretary, on this 27th day of June, 2013, and each such signatory does hereby acknowledge the same to be the act of the Corporation, and that to the best of his knowledge, information and belief, all matters and facts stated herein are true in all material respects, this statement being made under the penalties of perjury.
