Pursuant to the provisions of Chapter 2B, Article 10 of the Alabama Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE I

ARTICLE II

The following amendment to the Articles of Incorporation was duly adopted by the directors and shareholders of the corporation on the 13th day of December, 2002, in the manner prescribed by the Alabama Business Corporation Act:

ARTICLE III

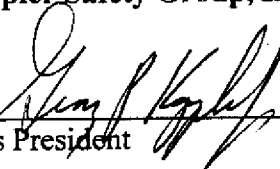
