**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

THIS RELEASE dated as of September 24, 2013 (this "Release") is made by Comerica Bank, as Agent, a Texas banking association, formerly a Michigan banking corporation (the "Secured Party"), under the Security Agreement dated as of December 13, 2005 (as amended, restated or otherwise modified from time to time, the "Security Agreement") by and between the Secured Party and HD Holdings, Inc., a Delaware corporation and HomeDirect, Inc., a Delaware corporation (the original grantees also included HD Acquisition Corporation, HD Intermediate Corp. and Bekins Worldwide Solutions, Inc.) (all grantees are collectively referred to as the "Debtors") and recorded in the records of the United States Patent and Trademark Office on December 19, 2005 at Trademark Reel 3212, Frame 0881 and on July 7, 2011 at Trademark Reel 4577, Frame 0234.

WHEREAS, pursuant to the Security Agreement, the Debtor granted to the Secured Party a security interest in the Debtors' trademarks, including but not limited to the trademarks listed on attached Exhibit A (the "Trademarks").

WHEREAS, the Secured Party wishes to: (i) release and terminate all of its security interest covering the Trademarks; (ii) restore all right, title and interest in and to the Trademarks to Debtors; and (iii) terminate any and all liens and encumbrances respecting the Trademarks under the Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party does hereby release and terminate its security interest in the Trademarks, and discharges, quit claims and relinquishes unto the Debtors (in each case without recourse and without any representation or warranty) any and all right, title and interest it has in and to the Trademarks under the Security Agreement.
