TRADEMARK ASSIGNMENT

WHEREAS, XYLEM GROUP, LLC, a limited liability company organized and existing under the laws of the State of Georgia having a place of business at 205 Hembree Park Drive, Suite 130, Roswell, Georgia 30076 (hereinafter referred to as "Assignor"), is the owner of all right, title and interest in and to the trademark XYLEM for bathroom and kitchen fixtures and bathroom furniture in International Classes 11 and 20 (the "Trademark"), and all goodwill related thereto, and is the owner of Registration Number 3,183,362 for the mark XYLEM issued by the U.S. Patent and Trademark Office on December 12, 2006 (the "U.S. Registration") and Registration Numbers T-25993, T-25994, T-25995 and T-25996 for the mark XYLEM issued by the Secretary of State of the State of Georgia on November 21, 2011 (collectively, the "Georgia Registrations"); and

WHEREAS, XYLEM IP HOLDINGS LLC, a corporation organized under the laws of the State of Delaware, with an office at 1209 Orange Street, Wilmington, Delaware 19801 ("Assignee"), is desirous of acquiring the Trademark and the goodwill associated therewith, the U.S. Registration, and the Georgia Registrations; and

WHEREAS, the assignment of the Trademark and the U.S. Registration shall be made of record in the United States Patent and Trademark Office; and

WHEREAS, Assignor agrees that it will execute or arrange for execution of such further assignment documents or other legal instruments as may be required, if any, from Assignor to permit Assignee to obtain recordation of the assignment of the Trademark, the U.S. Registration and the Georgia Registrations from Assignor to Assignee.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns and transfers to Assignee, free and clear of all liens and encumbrances, all right, title and interest of Assignor anywhere in the world in and to the Trademark, together with the goodwill of the business symbolized by the Trademark, the U.S. Registration, the Georgia Registrations, and all common or other law rights in or to the Trademark and any applications or registrations for the Trademark, as well as all rights to damages and profits, due or accrued, arising out of past infringements of the Trademark, and the right to sue and recover for same.

IN WITNESS WHEREOF, the parties have caused this Trademark Assignment to be signed by a duly authorized officer effective as of the 3rd day of October, 2013.


