TERMINATION OF SECURITY INTEREST IN TRADEMARK RIGHTS

THIS TERMINATION dated as of September 30, 2013 ("Termination") is made by LIONDOR INVESTMENTS LIMITED (the "Lender") under that certain Trademark Security Agreement dated as of July 29, 2011 (as amended and in effect immediately prior to the date hereof, the "Trademark Security Agreement") in favor of OASIS LEGAL FINANCE OPERATING COMPANY, LLC, a Delaware limited liability company (the "Grantor").

WITNESSETH:

WHEREAS, pursuant to the Trademark Security Agreement, the Grantor granted a security interest to the Lender in all of the Grantor's right, title and interest in, to and under its owned or thereafter acquired trademarks, including those set forth on the attached schedule (the "Trademark Collateral");

WHEREAS, the Trademark Security Agreement was recorded with the Trademark Division of the United States Patent and Trademark Office on September 20, 2011, at Reel 4626 and Frame 0872;


WHEREAS, the Grantor has requested and the Lender has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Trademark Collateral (the "Released Collateral");

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Lender does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Trademark Security Agreement in the Released Collateral, (b) release its security interest in the Released Collateral, and (c) discharge any and all rights, title and interest it has in and the security interest granted to the Lender in the Released Collateral.
