TERMINATION OF SECURITY INTERESTS IN PATENTS AND TRADEMARKS

This Termination of Security Interests in Patents and Trademarks, dated as of October 4, 2013, is made by FCC, LLC d/b/a First Capital (the "Secured Party").

WHEREAS, Woodbolt Distribution, LLC (the "Grantor") has granted a security interest in certain personal property to the Secured Party, including without limitation a security interest in all of the Grantor's right, title, and interest in and to: (i) trademarks, service marks, collective membership marks, registrations, and applications for registrations for each, and the respective goodwill associated with each; (ii) licenses, fees, or royalties with respect to each; (iii) the right to sue for past, present, and future infringement, dilution, and damages therefor; and (iv) licenses thereunder, all as presently existing or hereafter arising or acquired, including all of the marks referred to on Schedule A attached hereto (collectively, the "Trademarks"), and in all of the Grantor's right, title and interest in and to patents or applications for patents, fees or royalties with respect to each, and including without limitation the right to sue for past infringement and damages therefor, and licenses thereunder, all as presently existing or hereafter arising or acquired (collectively, the "Patents" and, together with the Trademarks and any other property covered by the Patent and Trademark Security Agreement dated as of July 1, 2010, by and among the Grantor and the Secured Party, the "Collateral");

WHEREAS, the security interest granted to the Secured Party was recorded at the United States Patent and Trademark Office on July 7, 2010, at Reel 4237 and Frame 0978; and

WHEREAS, the Secured Party has agreed to terminate and release its security interest in all of such Collateral.

NOW, THEREFORE, for valuable consideration, the Secured Party hereby terminates and releases all liens and security interests granted to the Secured Party in the Collateral, including but not limited to the following Trademarks:


- (1) All of the Grantor's Trademarks, including those referred to on Schedule A attached hereto; and
