CONFIRMATORY TRADEMARK ASSIGNMENT

THIS CONFIRMATORY ASSIGNMENT is *nunc pro tunc* effective as of the 21st day of September, 2010 (the “Effective Date”), from **THE PANTS SET, INC.**, a Delaware corporation with an office at 270 Duffy Avenue - Unit M, Hicksville, NY 11801 (“Assignor”), to **SYDNEY SIEGEL**, an individual domiciled in the State of Florida with an address at 7809 Dundee Lane, Delray Beach, FL 33446 (“Assignee”).

WHEREAS, Assignor and Assignee are parties to a Certificate of Sale Agreement dated as of the Effective Date (the “Sale Agreement”); and

WHEREAS, pursuant to the Sale Agreement and other agreements Assignor sold, conveyed, assigned, transferred, and delivered to Assignee, *inter alia*, the trademark EPIC DESIGNS, United States Trademark Registration No. 2,852,368 for the mark EPIC DESIGNS, and all goodwill associated with the EPIC DESIGNS mark, including all related marks and related goodwill; and

WHEREAS Assignor and Assignee wish to confirm the assignment from Assignor to Assignee of the entirety of Assignor’s right, title and interest in and to the trademark EPIC DESIGNS, United States Trademark Registration No. 2,852,368 for the mark EPIC DESIGNS, and all goodwill associated with the EPIC DESIGNS mark, including all related marks and related goodwill.

NOW, THEREFORE, for good and valuable consideration (including that recited in the Sale Agreement and the related agreements), the receipt and adequacy of which is hereby acknowledged, Assignor hereby confirms and sells, assigns, transfers and conveys to Assignee, its successors and assigns forever, free and clear of all liens and encumbrances, Assignor’s entire right, title and interest in the trademark EPIC DESIGNS, United States Trademark Registration No. 2,852,368 for the mark EPIC DESIGNS, and all goodwill associated with the EPIC DESIGNS mark, including all related marks and

related goodwill, together with the goodwill of Assignor's business appertaining thereto and/or symbolized thereby, all income, royalties, damages and payments now or hereafter due or payable in respect thereto, and all causes of action (either in law or in equity) and the right to sue, counterclaim and recover for past, present and future infringement and/or dilution of the mark and the rights thereto.

Assignee authorizes and requests the Commissioner of Patents and Trademarks of the United States, and any official of any country or countries foreign to the United States, whose duty it is to issue trademarks, to issue the same to the said Assignee, its successors and assigns, in accordance with the terms of this Assignment.
