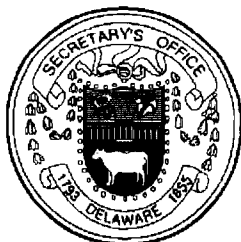

## ASSET PURCHASE AGREEMENT

**THIS ASSET PURCHASE AGREEMENT** (this "Agreement") is made as of September 12, 2008, by and among Mail.com Media Corporation, a Delaware corporation, with offices at 200 N. Sepulveda Boulevard, 2<sup>nd</sup> Floor, El Segundo, CA 90245 ("Parent"), Hollywood Life, LLC, a Delaware limited liability company, with offices at 200 N. Sepulveda Boulevard, 2<sup>nd</sup> Floor, El Segundo, CA 90245 ("Purchaser"), and Line Publications, LLC, a California Limited Liability Company, with offices at 10537 Santa Monica Boulevard, Suite 250, Los Angeles, CA 90025 ("Seller"), each individually a "Party" and collectively the "Parties."

### RECITALS

A. Seller operates and publishes *Hollywood Life* magazine and creates and hosts entertainment events and award shows (the "Business") as defined in this Agreement.

B. Seller and Parent presently operate an online website located at "www.hollywoodlife.net" under that certain Agreement for Formation and Organization of Hollywood Life Media, LLC, dated CONFIDENTIAL between Seller and Parent (the "Joint Venture Agreement").

C. Seller and Parent desire to terminate the Joint Venture Agreement, and Seller desires to sell to Purchaser the Business and all associated assets, and Purchaser desires to purchase the Business, and all of Seller's assets as set forth herein.

**NOW, THEREFORE**, in consideration of the mutual covenants of the Parties as hereinafter set forth and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby agree as follows:

1. Purchase and Sale of Assets. Seller shall sell, assign, transfer, convey and deliver to Purchaser, as of the Closing Date (as defined below), good and valid title to the Purchased Assets, free and clear of all, on the terms and subject to the conditions set forth in this Agreement. For purposes of this Agreement, the term "Purchased Assets" shall mean and include all of the properties, rights, interests and other tangible and intangible assets of Seller, related solely to the Business. Without limiting the generality of the foregoing, the Purchased Assets shall include:

(a) The *Hollywood Life* magazine, including any and all equipment, and intellectual property owned by the Seller used to facilitate the design, creation, printing, distribution, and sale of the *Hollywood Life* Magazine (the "Magazine")

(b) All assets required to operate and host all award shows and events owned and controlled by Seller, including, but not limited to Young Hollywood Awards, Breakthrough Of The Year Awards, Hollywood Style Awards, Young Hollywood Home, Hollywood Life House,



"Hamilton's" Behind the Camera Award, Hollywood Life House - Sundance, and Young Hollywood Dream Closet, and any other events, shows, and/or other media events which Seller owns or controls (the "Events").

(c) All of Seller's right, title and interest in and to all registered and unregistered statutory and common law copyrights and trademarks relating to the Business, together with all registrations, renewals and applications therefore, and all goodwill associated therewith, as defined in Exhibit A attached hereto (the "Marks")

(d) The "HollywoodLife.net", "Movieline.com" domain names, and any other domain names owned or controlled by Seller, to be listed in Exhibit B hereto (the "URL's").

(e) All rights and ownership in event video and other content material owned and controlled by Seller relating to the Business, including, but not limited to Young Hollywood Awards, Breakthrough Of The Year Awards, Hollywood Style Awards, Young Hollywood Home, Hollywood Life House, "Hamilton's" Behind the Camera Award, Hollywood Life House - Sundance, and Young Hollywood Dream Closet, and any other events, shows, and/or other media events for which Seller owns or controls video material.

(f) All other existing video material, written and pictorial content feeds, images, audio, stories, and any and all other archived materials or content, owned and controlled by Seller existing on the Closing Date, whether such content is archived, stored, published, or created in raw unedited formats, or has been edited, reduced to writing, or stored electronically, and all such video material, written and pictorial content feeds, images, audio, stories and any and all other archived materials or content, created by the Seller (the "Other Content").

(g) All goodwill of the Business.

(h) All office furniture, fixtures, fittings, and office equipment owned by the Seller as defined in Exhibit C attached hereto (the "Equipment").

(i) All accounts receivable, notes receivable, and all other receivables, due, or collected on, or after the Closing;

(j) Customer lists, historical customer data, customer contact information including, but not limited to; email addresses, mailing addresses, phone numbers, and all other customer-related materials or information possessed by Seller;

(k) All rights to collect from customers (and to retain) all fees and other amounts payable, or that may become payable.

(l) All books and records, and prior revenues relating to the Business;

(i) Section Headings. The Section headings contained herein are for convenience of reference and are not intended to define or limit the scope of any provision of this Agreement.

(j) Counterparts. This Agreement may be executed in one or more counterparts, each of which shall be deemed an original, and shall become effective and binding upon the Parties as of the Effective Date.

(k) Severability. The determination that any provision of this Agreement is invalid or unenforceable shall not invalidate this Agreement, and the remainder of this Agreement shall be valid and enforceable to the fullest extent permitted by law.

(l) Entire Agreement. This Agreement sets forth the entire understanding of the parties relating to the subject matter thereof and supersedes all prior agreements and understandings among or between any of the parties relating to the subject matter thereof except as expressly provided otherwise herein.



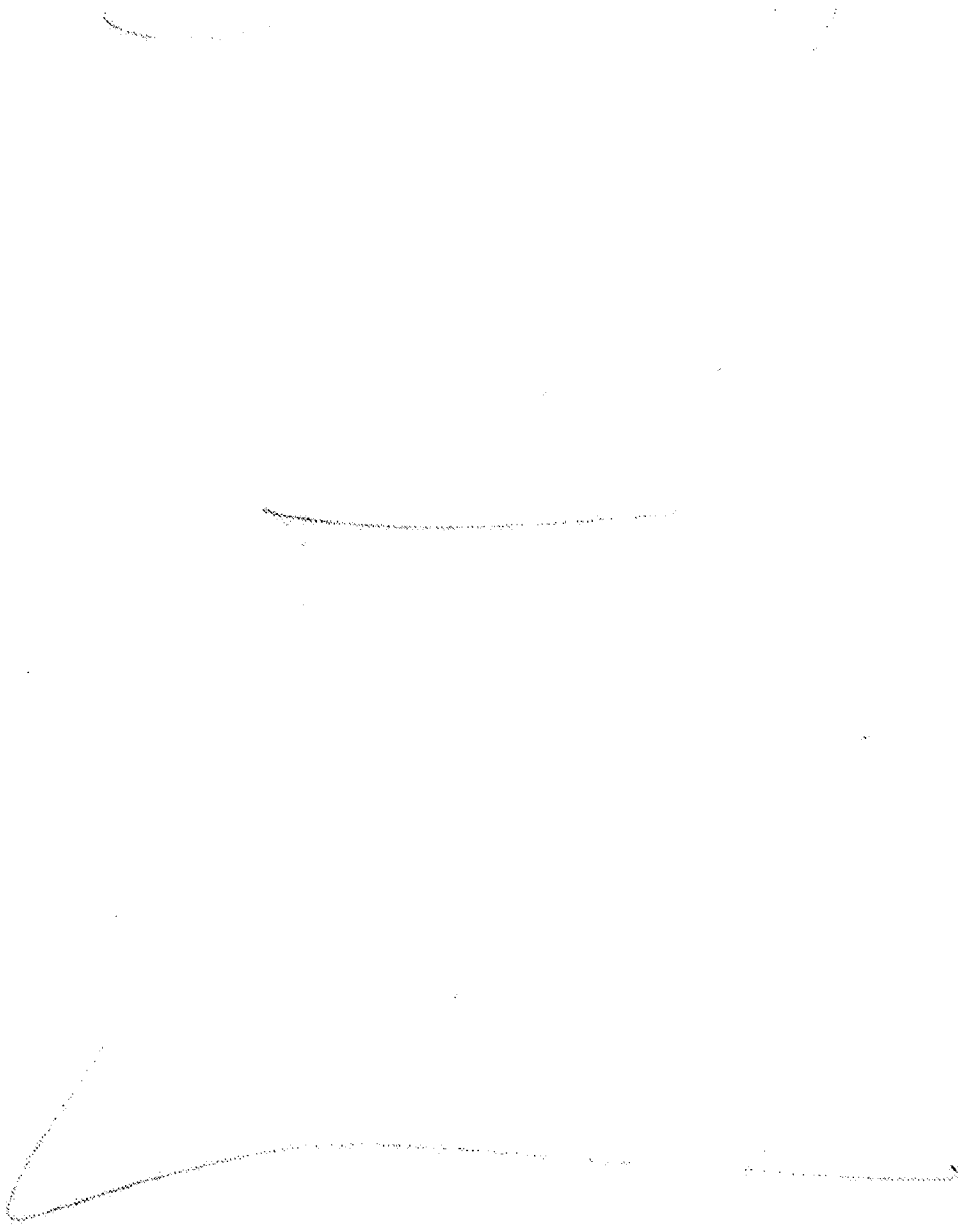
