TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT (this "Trademark Assignment") is made and executed as of this 21st day of June, 2013, but effective as of the 30th day of August, 2013, by and between Tenaxol Technologies, Inc., a Wisconsin corporation ("Assignor"), and The Lubrizol Corporation, an Ohio corporation ("Assignee"), in connection with that certain Asset Purchase Agreement, dated as of November 8, 2011, by and among Assignor, Assignee and certain of their respective Affiliates (the "Asset Purchase Agreement"). Capitalized terms used but not otherwise defined herein shall have the meanings assigned to such terms in the Asset Purchase Agreement.

1. Assignment. For value received, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby sells, assigns, transfers, conveys and delivers to Assignee the entire right, title and interest of Assignor in, to and under the trademarks listed on Exhibit A (the "Trademarks"), including all goodwill associated therewith, free and clear of all Liens except for Permitted Liens, together with all rights to injunctive relief, damages or profits, due or accrued, arising out of all causes of action, past and future, including infringement of the Trademarks, or any other violation or injury to the goodwill, and the right to sue for and recover the same in its own name and the name of its successors and/or assigns.

2. Further Assurances. Assignor shall at any time and from time to time after the date hereof, upon the reasonable request of Assignee, execute, acknowledge and deliver, or cause to be executed, acknowledged and delivered, all such further assignments, transfers, conveyances and assurances as may be required for assigning, transferring, conveying, assuring and confirming to Assignee the entire right, title and interest of Assignor in, to and under the Trademarks.

IN WITNESS WHEREOF, Assignor and Assignee have caused this Trademark Assignment to be executed as of the date first set forth above.

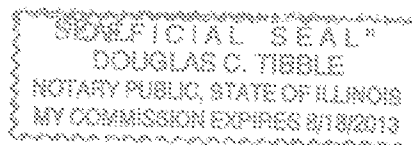

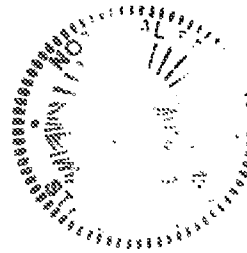
