ASSIGNMENT OF TRADEMARK RIGHTS

Whereas, Bryan Thompson (hereinafter referred to as "Thompson") is the owner of the common law and statutory rights to the trademarks "YELLOWHAMMER CHIPS" and "END FOOD BOREDOM" including the federal applications thereof (serial numbers 85/836775 and 85/915675) (hereinafter referred to as "the Trademarks");

Whereas, B & T By-Products, Inc., a Delaware corporation (hereinafter referred to as "B & T"), is desirous of acquiring the entire interest of Thompson in and to the Trademarks;

Now, therefore, for ten dollars (\$10) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Thompson does hereby sell, assign, convey and transfer to B & T all of Thompson's right, title and interest in and to the YELLOWHAMMER CHIPS trademark (including federal application number 85/836775) and END FOOD BOREDOM trademark (including federal application number 85/915675), and any modifications thereof, together with the goodwill of the business symbolized by the Trademarks and common law rights thereto, the same to be held and enjoyed by B & T, for its own use and benefit and that of its successors, assigns and legal representatives, together with all claims for damages by reason of past infringement, with the right to sue for and collect the same for its own use and for the use of its successors, assigns or other legal representatives.

Thompson represents and warrants to B & T that he has full right, power and authority to make this assignment to B & T in the manner set forth above, that Thompson is transferring to B & T complete, absolute, good, and marketable title to the Trademarks, free and clear of all liens, security interests, claims, interests, options, encumbrances, or indebtedness of any kind, and that no other person or entity has any other title or other interest in the Trademarks.

Thompson does hereby covenant and agree to execute and deliver such other and further instruments and take such other and further actions as may be necessary or appropriate to transfer to B & T any and all interest in and to the Trademarks.
