TRADEMARK AGREEMENT

In accordance with that certain Asset Purchase Agreement, dated October 4, 2013 (the "Asset Purchase Agreement"), by and among Cognizant Technology Solutions U.S. Corporation, a Delaware corporation ("Buyer"), Q Bridge, Inc., a Connecticut corporation ("Seller"), and, solely for the purposes of Sections 5.1, 5.2 and 5.4 and Article 7, Leon DeMaille, an individual, this Trademark Agreement (this "Trademark Agreement") is entered into as of the Closing Date (as defined in the Asset Purchase Agreement) by and between Buyer and Seller.

WHEREAS, Seller has agreed to assign to Buyer its entire rights, title, and interest worldwide to the trademarks and service marks comprising Q-BRIDGE, Q-CENTRAL, PRM, and PROSPECT RELATIONSHIP MARKETING (collectively, "Q Bridge Marks" shown in Annex 1 of this Trademark Agreement), as identified in applications filed with the United States Patent and Trademark Office as Application Serial Nos. 85272875 (filed March 21, 2011); and 85299256 (filed April 19, 2011); and 85299286 (filed April 19, 2011); and 85299301 (filed April 19, 2011)). The Q Bridge Marks also include any related trademarks and trademark applications filed with any other country or regional authority of the world and any associated or modified trademarks and service marks, and the goodwill appurtenant thereto; and


WHEREAS, the parties have agreed to enter into this separate Trademark Agreement to provide for the details of said assignment and license.
