
interests in and to the Marks together with the goodwill of the business symbolized by the Marks, including the registrations therefor and the sole right to enforce rights in said Marks.



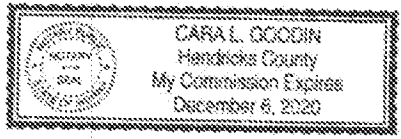

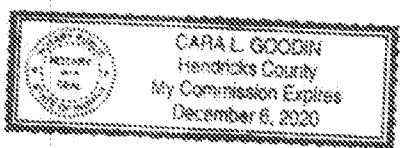
