Release of Security Interest in Trademarks and Patents

WHEREAS, Affymetrix, Inc., certain of its subsidiaries and General Electric Capital Corporation, in its capacity as Agent (the “**Agent**”) for the Secured Parties (as each term is defined in the GCA (as defined below)), entered into that certain Guarantee and Security Agreement (the “**GSA**”) dated June 25, 2012;

WHEREAS, pursuant to the GSA, the Agent and Affymetrix, Inc. (the “**Assignee**”) entered into that certain Trademark Security Agreement dated June 25, 2012 and recorded with the United States Patent and Trademark Office on June 25, 2012 on Reel No. 4807, Frame 0853 (the “**Trademark Security Agreement**”);

WHEREAS, pursuant to the GSA, the Agent and Affymetrix, Inc. (the “**Assignee**”) entered into that certain Patent Security Agreement dated June 25, 2012 and recorded with the United States Patent and Trademark Office on June 27, 2012 on Reel No. 028465, Frame 0541 (the “**Patent Security Agreement**”);

WHEREAS, under the Trademark Security Agreement, the Assignee granted to the Agent a security interest in certain Trademark Collateral (as defined in the Trademark Security Agreement), including those items set forth on Schedule 1 hereto (such items set forth on Schedule 1 hereto, the “**Released Trademark Collateral**”);

WHEREAS, under the Patent Security Agreement, the Assignee granted to the Agent a security interest in certain Patent Collateral (as defined in the Patent Security Agreement), including those items set forth on Schedule 2 hereto (such items set forth on Schedule 2 hereto, the “**Released Patent Collateral**”, and together with the Released Trademark Collateral, the “**Released Intellectual Property Collateral**”); and

WHEREAS, the Agent desires to release the security interest granted by the Assignee under the Trademark Security Agreement and under the Patent Security Agreement in the Released Intellectual Property Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent, as Agent for the Secured Parties, does hereby unconditionally, irrevocably and absolutely terminate, release, extinguish and forever discharge the security interest granted under the Trademark Security Agreement and the Patent Security Agreement in the Released Intellectual Property Collateral, together with all of the goodwill of the business connected with the use of, or symbolized by, such Released Intellectual Property Collateral, and hereby unconditionally, irrevocably and absolutely assigns, transfers and conveys to the Assignee all right, title and interest of the Agent in, to and under such Released Intellectual Property

Collateral and such goodwill granted under the Trademark Security Agreement and the Patent Security Agreement. This Release of Security Interest in Trademarks and Patents shall be binding upon the Agent's legal representatives, assigns and successors and upon the Secured Parties. The Agent also hereby authorizes, and requests, the Director of the United States Patent and Trademark Office or his delegate to record this Release of Security Interest in Trademarks and Patents against the Released Intellectual Property Collateral.
