TRADEMARK AND SERVICE MARK ASSIGNMENT

2. Assignor and Assignee acknowledge that this transfer is being made in connection with the sale to Assignee of all or substantially all of the assets of Assignor's business to which the Trademarks relate and that business is ongoing and existing.

3. Assignor covenants that it will do, execute, and deliver, or will cause to be done, executed, and delivered all such further acts or documentation for the better of assuring, assigning, conveying, transferring, granting, and confirming unto Assignee, all of each Assignor's entire right, title, and interest in and to the Trademarks as Assignee may reasonably require.


4. This Assignment shall be construed in accordance with the laws of the State of Georgia, without regard to the principles of conflict of laws thereunder.
