INTELLECTUAL PROPERTY SECURITY AGREEMENT TERMINATION

THIS INTELLECTUAL PROPERTY SECURITY AGREEMENT TERMINATION is made effective as of October 11, 2013, by and from Investec Bank (UK) Ltd., now Investec Bank PLC, as Administrative Agent ("**Agent**"), for the Lenders under the Loan and Security Agreement, dated as of June 27, 2007, between Sonim Technologies, Inc., a Delaware corporation (the "**Company**"), and Agent, to the Company as follows:

WHEREAS, the Company and Agent entered into the Intellectual Property Security Agreement, dated as of June 27, 2007 (the "**Intellectual Property Security Agreement**"; capitalized terms used but not defined herein shall have the meanings given them in the Intellectual Property Security Agreement);

WHEREAS, the Intellectual Property Security Agreement was recorded in the United States Patent and Trademark Office on July 10, 2007, at (i) Reel 019529 and Frame 0923 for published patents and (ii) Reel 3577 and Frame 0750 for trademarks;

WHEREAS, pursuant to the Intellectual Property Security Agreement, the Company granted Agent, on behalf of the Lenders, a security interest in all of Borrower's right, title and interest in, to and under the patents listed on the attached Exhibit A (the "**Patents**"), the trademarks listed on the attached Exhibit B (the "**Trademarks**") and all trademark applications, trademark registrations, pending patents and patents acquired or arising after the date of the Intellectual Property Security Agreement (the Patents, the Trademarks and such other intellectual property the "**Intellectual Property**");

WHEREAS, the Company has or has caused to be paid and satisfied in full the obligations for which the security interest in the Intellectual Property was granted; and

WHEREAS, the Agent wishes to release its security interest in the Intellectual Property;




The Agent further agrees, for itself, its successors and assigns, to execute, at the Company's expense, such further documents, and to perform such further lawful acts, as may reasonably be requested by the Company to effectuate this termination.
