**RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

**THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY** (this "Release") is made as of April 7, 2008 ("Effective Date") by and between ORIX Venture Finance LLC ("ORIX") and Accruent, LLC, formerly known as Accruent, Inc. ("Grantor").

**WHEREAS**, pursuant to the terms and conditions of that certain INTELLECTUAL PROPERTY SECURITY AGREEMENT by and between Grantor and ORIX dated as of June 23, 2006 (the "Security Agreement"), Grantor granted to ORIX a security interest in and to all of Grantor's right, title and interest in and to all of the Grantor's Intellectual Property (as defined in the "Security Agreement") (collectively, the "Collateral"), including, without limitation, the trademark registrations, in each case together with the goodwill associated therewith, the copyright registrations, and the patents set forth on Schedule A attached hereto;

WHEREAS, Grantor and ORIX entered into the Security Agreement pursuant to the terms and conditions of that certain Loan and Security Agreement dated as of June 23, 2006 between Grantor and ORIX (the "Loan Agreement");

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office ("PTO") on August 25, 2006, at Reel 3377 and Frame 0513, and Reel 018172 Frame 0560; and

WHEREAS, Grantor has paid all of its outstanding indebtedness to ORIX.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, ORIX hereby terminates the Security Agreement and the Loan Agreement, and hereby terminates, cancels and releases any and all security interests it has against the Collateral.

ORIX represents and warrants that: (i) it has the full power and authority to execute this Release; and (ii) it has not assigned, transferred, restricted or otherwise encumbered any security interest it has against the Collateral.

ORIX shall, at Grantor's expense, take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release.
