### Release of Trademark Security Agreement

WITNESSETH:

WHEREAS, pursuant to a Grant of Trademark Security Interest dated as of May 10, 2007 (the "IP Security Agreement"; any capitalized term used but not otherwise defined herein shall have the meaning assigned to such term in the IP Security Agreement) between the Grantor and the Security Agent, which IP Security Agreement was recorded in the U.S. Trademark Office (the "Office") on May 14, 2007, at Reel 3546, Frame 0672, the Grantor has granted a security interest in its right, title and interest in and to the intellectual property listed in Schedule 1 (the "Intellectual Property") to the Security Agent, for the benefit of the Secured Parties.

WHEREAS, in connection with the full satisfaction and discharge of all Secured Obligations, the Secured Parties have agreed to release the security interests created under the IP Security Agreement on the terms and conditions set forth in that certain Payoff of Indebtedness and Release of Lien letter, dated as October 3, 2013, from the Security Agent to the Borrower.

NOW, THEREFORE, in consideration of the foregoing and for other valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Security Agent, acting on behalf of the Secured Parties, hereby releases the security interests over the Intellectual Property created by the IP Security Agreement as of the date first written above.


