AND the Assignor hereby requests that any and all aforementioned Marks be issued to the Assignee, as the Assignee of the Marks to be issued thereon for the sole use and benefit of the Assignee, its successors and assigns.

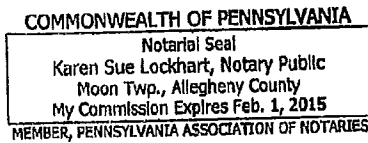

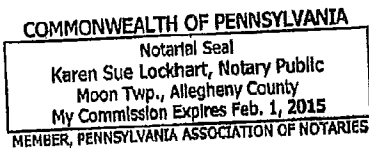

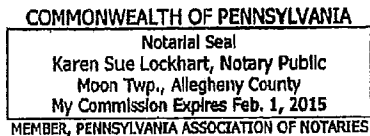
