## RELEASE AND TERMINATION OF SECURITY INTEREST

THIS RELEASE AND TERMINATION OF SECURITY INTEREST, dated as of September 18, 2013, is made by C3 CAPITAL PARTNERS, L.P. ("Lender").

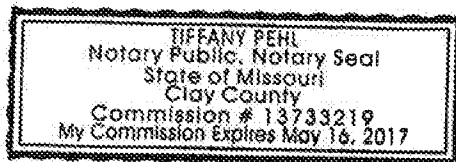
