DISCHARGE OF SECURITY INTEREST
(Trademarks)

WHEREAS, FORUM COMMUNICATIONS COMPANY, a North Dakota corporation (the “Grantor”) granted a security interest in the United States trademarks listed in Exhibit A attached hereto and in the other collateral described in the Agreement (as defined below) (collectively, the “Collateral”) to U.S. BANK NATIONAL ASSOCIATION, as Agent (the “Secured Party”) for the benefit of the Banks (as such terms are defined in the Agreement), in order to secure repayment of certain amounts owing to the Banks;

NOW THEREFORE, to all who it may concern be it known that for and in consideration of the payment to the Secured Party of the full amount of the Indebtedness, the Secured Party hereby (a) releases and discharges all the security interests granted by the Agreement, being the security interests granted in respect of the patents, trademarks, copyrights and all other Collateral and (b) acknowledges, confirms and agrees that the Agreement is discharged, released and terminated and of no further force or effect.
