

RELEASE OF SECURITY INTEREST IN CERTAIN INTELLECTUAL PROPERTY  
(TRADEMARKS)

This RELEASE OF SECURITY INTEREST IN CERTAIN INTELLECTUAL PROPERTY (this "Release") is made as of October 15, 2013, by Commerzbank AG, Luxembourg Branch as Security Agent ("Security Agent") in favor of Britax Childcare Holdings Limited, a private limited company incorporated in England and Wales ("Grantor"). All capitalized terms used but not otherwise defined herein shall have the meanings ascribed to such terms in the U.S. Intellectual Property Security Agreement, dated as of January 14, 2011 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), among, *inter alios*, Grantor and the Security Agent.

WHEREAS reference is made to the Senior Facilities Agreement, dated 10 January 2011 (as amended and restated on 13 October 2011 and as otherwise amended, supplemented, or modified prior to the date hereof, the "Senior Facilities Agreement"), among, *inter alios*, the Grantor, the Lenders (as defined therein) and the Security Agent;

WHEREAS, Grantor has granted to Security Agent, a security interest in and to all of such Grantor's right, title and interest in and to the Intellectual Property Collateral (as defined in the IP Security Agreement), including trademark registration and trademark applications set forth on Schedule A attached hereto (the "Released IP") to secure the prompt and complete payment and performance of the obligations of the Secured Obligations; and

WHEREAS the IP Security Agreement was recorded on March 25, 2012 with the United States Patent and Trademark Office under Reel and Frame number 4488/0061;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Security Agent agrees as follows:

- (a) Security Agent, on behalf of the Secured Parties, hereby relinquishes, releases, discharges and assigns to Grantor its security interest and lien in, to and under the Released IP.
- (b) Security Agent hereby authorizes and requests that the Commissioner for Patents and Trademarks and any other applicable government officer record this Release.
- (c) This Release shall be governed by, and construed in accordance with the law of the State of New York.

IN WITNESS WHEREOF, the Security Agent has caused this RELEASE OF SECURITY INTEREST IN CERTAIN INTELLECTUAL PROPERTY to be duly executed as of the date first written above.
