## RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE OF TRADEMARK SECURITY INTEREST (the "Release") is made as of the 8th day of October, 2013, by Contrarian Financial Service Company, LLC, a Delaware limited liability company (together with its successors and assigns, the "Lender"), a party to the Second Lien Loan and Security Agreement ("Security Agreement"), to and for the benefit of Central Florida Press, LLC, a Florida limited liability company ("CFP").

### WITNESSETH:

Releases all of its security interest in the trademarks, registrations, licenses and applications of CFP including those listed in Schedule A attached hereto, and in all of the goodwill of the business connected with the use of, and symbolized by, each such trademark, and in all uses, products and proceeds of the foregoing.
2. Authorizes and requests Commissioner of Patents and Trademarks of the United States of America to record the Release of Trademark Security Interest granted hereunder with respect to the trademarks, licenses and applications including those listed in Schedule A attached hereto.



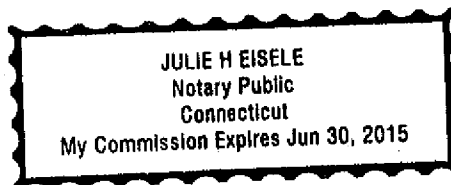
