## TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "Assignment") is made effective as of March 20, 2013 between FISERV, INC., a Wisconsin corporation ("Assignor"), and FISERV CSW, LLC, a Delaware limited liability company ("Assignee").

### RECITALS

- A. Assignor is the sole member of Assignee, and Assignee is a wholly-owned subsidiary of Assignor.
- B. Assignor is the owner of the Assigned Trademarks (as defined below).
- C. Assignor desires by execution of this Assignment to confirm the assignment of all right, title and interest in and to the Assigned Trademarks to Assignee, and Assignee desires by execution of this Assignment to confirm the assignment of all of Assignor's right, title, and interest in the Assigned Trademarks to Assignee.

### AGREEMENT

For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns the Assigned Trademarks as follows:

1. Definition of the Assigned Trademarks. The term "Assigned Trademarks" shall mean the trademark registrations listed in Appendix A, as well as: (a) all common law rights therein; (b) all goodwill associated therewith; (c) all renewals thereof; and (d) all rights of action, powers and benefits accrued thereto, including the right to sue for and/or initiate any proceeding to collect damages and payments for past, present or future infringements thereof.
2. Assignment of the Assigned Trademarks. Assignor hereby assigns and transfers to Assignee, its successors and assigns all of Assignor's right and title to and interest in the Assigned Trademarks. Assignor assigns and transfers the right and title to and interest in the Assigned Trademarks "as is" and makes no representations or warranties hereunder related to the Assigned Trademarks.
3. Governing Law. This Assignment shall be governed by the laws of the State of Wisconsin and the federal laws of the United States without giving effect to any rule or provision thereof which would cause the application of the law of any other state.
4. Facsimile Signature; Counterparts. This Assignment may be executed by facsimile delivery or other electronic means (i.e., PDF) of original signatures and in counterparts, each of which shall be considered one and the same agreement, and shall become effective when such counterparts have been signed by each party and delivered to the other party.


