TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of October 15, 2013, by BARCLAYS BANK PLC, as collateral agent (“Collateral Agent”). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

WITNESSETH:

WHEREAS, WILSHIRE OPERATIONS LLC, a Delaware limited liability company, WILCON HOLDINGS LLC, a Delaware limited liability company, WILSHIRE CONNECTION, LLC, a Delaware limited liability company, IX2 CENTER, L.L.C., a Delaware limited liability company, IX2 WILSHIRE, LLC, a California limited liability company, NTC NETWORK, LLC, a California limited liability company (collectively, the “Grantors”) and Collateral Agent were parties to a Trademark Security Agreement dated as of May 10, 2012 (the “Security Agreement”), pursuant to which the Grantors granted a security interest to Collateral Agent in certain trademarks (“Trademarks”) and Trademark Collateral (as defined below) as security for certain obligations owing by Grantors to Collateral Agent, including the Trademark set forth on Schedule 1 hereto; and

WHEREAS, the Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on May 10, 2012, at Reel 4776, Frame 0953; and

WHEREAS, the Grantors have requested that Collateral Agent release its security interest in the Trademarks and Trademark Collateral and reassign any and all rights in the same to the Grantors.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Collateral Agent hereby releases its security interest in all of each Grantor’s right, title and interest in and to the following (collectively the “Trademark Collateral”):

- (i) each Trademark, Trademark registration and Trademark application owned by the Grantors, including, without limitation, the Trademarks, Trademark registrations and Trademark applications referred to in Schedule 1 annexed hereto;
- (ii) all extensions or renewals of any of the foregoing;
- (iii) all of the goodwill of the business connected with the use of and symbolized by any of the foregoing;

(iv) the right to sue or otherwise recover for any past, present and future infringement, dilution or other violation of any of the foregoing or for any injury to the related goodwill;

(v) all proceeds of the foregoing, including, without limitation, license fees, royalties, income, payments, claims, damages and proceeds of suit now or hereafter due and/or payable with respect thereto; and


(vi) all other rights of any kind accruing thereunder or pertaining thereto throughout the world.

2. Collateral Agent hereby reassigns, grants and conveys to the Grantors, without any representation, recourse or undertaking by Collateral Agent, any and all of Collateral Agent's right, title and interest in and to the Trademarks and the Trademark Collateral.
