TRADEMARK ASSIGNMENT

This Trademark Assignment agreement ("Trademark Assignment") is entered into by and among Nyakio Brands, LLC ("Company"), a California limited liability company, Nyakio Kamoche Grieco ("Nyakio"), and Gurwitch Products, L.L.C., a Delaware limited liability company ("Gurwitch").

WHEREAS, Company and/or Nyakio owns common law trademark rights for the marks

NYAKIO ("NYAKIO Mark") and  (hereinafter, "the NYAKIO Logo") in connection with the following products:

Raspberry Basil Body Crème; Grapefruit Tarragon Body Crème; Kenyan Coffee & Sugar Body Scrub; Lemon Rind & Sugar Body Scrub; Grape Eucalyptus & Sugar Body Scrub; Citrus Moluccana Oil-Based Body Wash; Kiwi Aloe Oil-Based Body Wash; Dry Oil Spray; Kitale Serum; Mobasa candle; African Tea candle; Chai Fragrance Diffuser; Ocean Fragrance Diffuser; Pomegranate & Sage Diffuser; Coconut Palm Diffuser; White Orchid Diffuser; Perfume Oil; Travel Kit comprising scrubs, serum (body oil), body washes, body crème, and perfume.

WHEREAS, Company has obtained United States Trademark Registration No. 2,856,415 ("NYAKIO Registration"); and

WHEREAS, Company has filed U.S. Trademark Application No. 77/788,816 ("NYAKIO Application") based on Company's bona fide intent to use the mark in commerce in connection with the goods identified in the application; and

WHEREAS, Gurwitch Products, L.L.C., a Delaware limited liability company ("Gurwitch") desires to acquire all Company's right, title and interest in and to the rights in the NYAKIO Mark, the NYAKIO Logo, the NYAKIO Registration and the NYAKIO Application;

NOW THEREFORE:

1. Company and/or Nyakio hereby sells, assigns and transfers to Gurwitch all right, title and interest in and to the NYAKIO Mark, the NYAKIO Logo the NYAKIO Registration and the NYAKIO Application, together with all goodwill relating thereto.
2. This assignment shall be effective as of the earlier of the filing of an allegation of use for or abandonment of the NYAKIO Application.
