TRADEMARK RELEASE OF SECURITY INTEREST

THIS TRADEMARK RELEASE OF SECURITY INTEREST is made as of October 15, 2013, by GENERAL ELECTRIC CAPITAL CORPORATION, in its capacity as administrative Agent ("Agent").

WITNESSETH:

WHEREAS, Agent and RANDALL-REILLY PUBLISHING COMPANY, LLC ("Grantor"), were parties to those certain Trademark Security Agreements dated as of (i) March 12, 2004¹, (ii) January 19, 2007, (iii) October 31, 2007, (iv) February 29, 2008, (v) May 20, 2008, (vi) October 29, 2009, (vii) March 9, 2010, (viii) May 28, 2010, (ix) August 31, 2010, and (x) November 17, 2010, (each a "Security Agreement"; capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in each Security Agreement), pursuant to which Grantor, on behalf of itself and Lenders, granted a security interest to Agent in, among other things, all of Grantor's right, title and interest in, to and under the Trademark Collateral, including the Trademarks set forth on Exhibit A hereto; and

WHEREAS, Grantor has requested that Agent release its security interest in the Trademarks set forth on Exhibit A and reassign the same to Grantor;

1. Agent hereby releases its security interest in all of Grantor's right, title and interest in, to and under the Trademark Collateral set forth on Exhibit A.
2. Agent hereby reassigns, grants and conveys to Grantor, without any representation, warranty, recourse or undertaking by Agent, all of Agent's right, title and interest in, to and under the Trademark Collateral, and the goodwill of Grantor's business connected with the use of and symbolized by the Trademark Collateral.
