RELEASE OF GRANT OF SECURITY INTEREST-- TRADEMARKS

WHEREAS, pursuant to that certain Grant of Security Interest - Trademarks, dated November 25, 2008 (the "Trademark Security Agreement"), recorded in the United States Patent and Trademark Office at Reel 3894, Frame 0349 on November 25, 2008, Hanna Andersson, LLC ("Releasee"), granted to Ableco Finance LLC, as the Collateral Agent for itself and certain lenders ("Releasor"), a continuing security interest in all of Releasee's right, title and interest in, to and under the Trademarks (as defined in the Trademark Security Agreement), including those referred to on Schedule I attached hereto, together with, among other things, the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (the "Collateral") to secure the payment, performance and observance of the Secured Obligations (as defined in the Trademark Security Agreement);

WHEREAS, Releasee has requested and Releasor has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Collateral.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Releasor hereby relinquishes, releases and discharges its security interest in and to the Collateral. Releasor further agrees to execute and deliver to Releasee any and all further documents or instruments and do any and all further acts which Releasee (or Releasee's agents or designees) reasonably request in order to confirm this release and Releasee's right, title and interest in and to the Collateral.
