RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST is made effective as of August 29, 2013, by and from SILICON VALLEY BANK, as Administrative Agent for the Lenders (the "Administrative Agent") to ENOM, INCORPORATED, a Nevada corporation (the "Grantor") as follows:

WHEREAS, on August 4, 2011, the Grantor and the Administrative Agent entered into an Intellectual Property Security Agreement (the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, the Grantor granted to the Administrative Agent on behalf of the Secured Parties, among other collateral, a continuing security interest in all of Grantor's right, title and interest in, to and under the Trademarks, including the United States Trademarks listed on the attached Schedule A, then owned or from time to time after the date thereof owned or acquired by the Grantor;

WHEREAS, the Security Agreement was recorded in the United States Patent and Trademark Office on August 5, 2011 at Reel 4598 and Frame 438; and on March 28, 2013 at Reel 4994 and Frame 49; and

WHEREAS, the Administrative Agent wishes to release its security interest in the foregoing.

NOW THEREFORE, the Administrative Agent hereby releases any security interest it may have in the Trademarks, including any goodwill of the business symbolized by the foregoing and all rights to sue for past, present, and future infringements thereof, and retransfers and reassigns any and all right, title and interest it may have in and to the foregoing without recourse to Grantor.
