TRADEMARK SECURITY INTEREST RELEASE

WHEREAS, The Denver Post LLC, a Delaware limited liability company ("Grantor"), and Alden Global Capital LLC, in its capacity as administrative agent for certain lenders (the "Agent"), entered into a Trademark Security Agreement dated January 14, 2013 (the "Trademark Security Agreement"), recorded in the United States Patent and Trademark Office at Reel/Frame 004944/0757, and a Security Agreement dated January 14, 2013 (the "Security Agreement", and together with the Trademark Agreement, the "Collateral Documents"), pursuant to which, among other things, Grantor granted to the Agent a continuing security interest in all of Grantor's right, title and interest in and to (i) the trademarks listed in Schedule A attached hereto (the "Trademarks") and (ii) all proceeds of the foregoing, including any claim by Grantor against third parties for past, present or future infringement or dilution of any Trademark (collectively, the "Trademark Collateral"); and

WHEREAS, Grantor and the Agent wish to provide a document suitable for recording in the United States Patent and Trademark Office ("USPTO") for purposes of recording the relinquishment, release and discharge of the Agent's security interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the Agent hereby relinquishes, releases and discharges its security interest in the Trademark Collateral granted to the Agent under the Collateral Documents and authorizes Grantor to seek the cancellation of the Trademark Security Agreement from the register of the USPTO where it was recorded on January 17, 2013.

IN WITNESS WHEREOF, the Agent, by signature below of its duly authorized representatives, agrees to be bound by the provisions of this Trademark Security Interest Release dated October 17, 2013.
