After the execution of this Assignment, at the request of Hydrofarm and at Hydrofarm's expense, but without additional consideration to Assignors, each of the Assignors will execute and deliver to Hydrofarm from time to time such further instruments of conveyance, transfer, and assignment and other documents, and will take such other actions, as Hydrofarm may reasonably require to convey and deliver more effectively to Hydrofarm the Marks, to perfect Hydrofarm's title thereto, and otherwise to accomplish the orderly transfer to Hydrofarm of the Marks and to give full effect to this Assignment.

This Assignment is binding on Assignors, and each of them, and their respective successors, heirs, personal representatives and assigns, and inures to the benefit of Hydrofarm and its successors and assigns.


