Releasor hereby assigns unto Releasee its entire right, title and interest in and to the Trademarks, including the right to recover for past infringement of any of the Patent and Trademark Collateral of Releasee or the Trademark Collateral of Releasee and the goodwill of the business in connection with which the Patent and Trademark Collateral of Releasee or the Trademark Collateral of Releasee are used and which is symbolized by any of the Patent and Trademark Collateral of Releasee or the Trademark Collateral of Releasee.

Releasor will execute such Uniform Commercial Code amendment statements as Releasee may reasonably request in order to evidence the termination of any security interest Releasor may have in and to the Trademarks and to execute such other documents and instruments, and take other such actions (at the expense of Releasee) as Releasee may reasonably request to evidence this termination and release and the release of any security interests in the Trademarks.
