Confirmatory Assignment of Trademark to Successor Entity

WHEREAS, Center Bank was, at all times relevant hereto, a California corporation located and doing business at 3435 Wilshire Boulevard, Suite 700, Los Angeles, California 90010 (hereinafter "CENTER BANK"), and was the sole owner of the entire right, title and interest in and to United States Trademark Registration No. 2,784,738, the mark "INNOVATIVE BANK" which forms the subject matter thereof, and the goodwill appertaining thereto (hereinafter the mark, goodwill and registration are collectively referred to as "the INNOVATIVE BANK Mark");

WHEREAS, all assets of CENTER BANK, including without limitation the INNOVATIVE BANK Mark, were acquired by BBCN Bancorp, Inc., a Delaware corporation with offices at 3731 Wilshire Boulevard, Suite 1000, Los Angeles, CA 90010 (hereinafter "BBCN"); and

WHEREAS, the purchase and purchase agreements between CENTER BANK and BBCN grant the undersigned as an officer of BBCN the right to execute this Confirmatory Assignment on behalf of both CENTER BANK and BBCN.

NOW THEREFORE, it is hereby confirmed that, for a valuable consideration, the receipt and sufficiency of which is hereby acknowledged, CENTER BANK assigned to BBCN the entire worldwide right, title and interest in and to the INNOVATIVE BANK Mark, including without limitation all common law and statutory rights therein, together with the good will of the business symbolized thereby, the above-identified registration thereof, the right to sue for past infringement, and any and all foreign rights to and registrations thereof.

It is respectfully requested that the Commissioner of Trademarks of the United States of America and equivalent officials in foreign countries record this Confirmatory Assignment and transfer title to the INNOVATIVE BANK Mark to BBCN.
