LSN, Inc. (the "*Corporation*"), a corporation organized and existing under the laws of the State of Georgia,

DOES HEREBY CERTIFY:

FIRST: That the present name of the Corporation is LSN, Inc.;

SECOND: That the Corporation elects to convert into a Delaware corporation (the "*Delaware Corporation*") pursuant to Section 265 of the Delaware General Corporation Law and Section 14-2-1109.3 of the Georgia Business Corporation Code (the "*Code*");

THIRD: That the name of the Delaware Corporation will be LSN Mobile, Inc.;

FOURTH: A Plan of Conversion to convert to a Delaware corporation has been authorized and approved by unanimous consent of the directors and the shareholders of the Corporation as required by Section 14-2-1109.3(c) of the Code;

FIFTH: The authority of the Corporation's registered agent to accept service on the Corporation's behalf is hereby revoked as of the effective time of the conversion (the "*Effective Time*"). 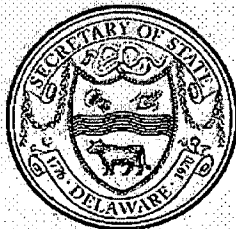
