TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (the "Assignment") is effective as of the 30th day of May, 2012 ("Effective Date") by and between **EUGENE PIPE, LLC**, an Oregon limited liability company having a place of business at 2220 Nugget Way, Eugene, OR 97403 (the "Assignor") and **EP LENDERS II, LLC**, an Oregon limited liability company having a place of business at 2220 Nugget Way, Eugene, OR 97403 (the "Assignee").

common law rights connected therewith, together with the goodwill of the business with respect to which the Trademarks or any such other marks or names have been used and/or registered and all claims, proceeds and causes of action relating to past, present or future infringement of said Trademarks or said other marks or names.

Assignor hereby requests the Commissioner of Patents and Trademarks to record Assignee, as assignee and owner of any and all of Assignor's joint ownership right in the Trademarks and to issue to Assignee any renewals of said registration.

Assignor agrees to execute and deliver at a future date, for no additional consideration any additional documents that the Assignee reasonably determines are required to reflect the Assignee's ownership of the Trademarks anywhere in the world.

Assignor will assist in obtaining or providing any further documents which may be required to confirm chain or title thereto.

This Assignment may be signed in counterparts, each of which shall be deemed an original, but together shall constitute a single instrument.
