SECURITY INTEREST IN TRADEMARKS**

**This RELEASE AND TERMINATION OF SECURITY INTEREST IN TRADEMARKS** ("Release and Termination") is executed as of October 18, 2013, by **JPMORGAN CHASE BANK, N.A.**, as administrative agent (the "Agent"), with reference hereby made to that certain Trademark Security Agreement dated as of May 14, 2012 (the "Security Agreement"), by **PERSONAL COMMUNICATIONS DEVICES, LLC**, a Delaware limited liability company, in favor of the Agent.

**WHEREAS**, the Borrower has requested that the Agent release the lien and security interest granted to it in the right, title and interest in and to the trademarks of the Borrower, together with the goodwill of the business symbolized thereby, set forth on Schedule I attached hereto (the "Trademarks"), pursuant to the Security Agreement.

The Agent does hereby certify that the security interests it holds in the right, title and interest to the Trademarks, pursuant to Security Agreement, which was recorded with the United States Patent and Trademark Office on May 14, 2012 at Reel/Frame: 4779/0436; are released and terminated and all interests in such property previously assigned to the Agent under the Security Agreement are hereby reassigned to the Borrower, without recourse or representation or warranty, express or implied, of any kind.

This Release and Termination shall be governed by the laws of the State of New York and shall relate solely to the Security Agreement.

The Agent authorizes and requests that the Commissioner for Trademarks and any other applicable United States government officer record this Release and Termination.
