TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Termination and Release"), dated as of October _____, 2013 is granted by WELLS FARGO BANK, NATIONAL ASSOCIATION, a national banking association, located at One Boston Place, 18th Floor, Boston, Massachusetts 02108, as successor by merger to WACHOVIA BANK, NATIONAL ASSOCIATION, now known as WELLS FARGO BANK, NATIONAL ASSOCIATION ("Wachovia Bank"), and thereby successor by merger to FIRST UNION NATIONAL BANK, now known as WELLS FARGO BANK, NATIONAL ASSOCIATION ("First Union National Bank"), as Administrative Agent (the "Administrative Agent"), in favor of VYCOM CORP., a Delaware corporation, now known as AZEK BUILDING PRODUCTS, INC. ("Vycom"), and COMPRESSION POLYMERS CORP., a Delaware corporation, now known as SCRANTON PRODUCTS INC. ("Compression Polymers").

WHEREAS, pursuant to that certain Security Agreement, dated as of March 1, 2001 (as may have been amended, modified, extended or restated from time to time), made by Vycom and Compression Polymers in favor of First Union National Bank (the "First Union Security Agreement"), a security interest (the "First Union Security Interest") was granted, among others, in certain trademarks and trademark applications (the "First Union Trademarks"), including the First Union Trademark Collateral (as hereinafter defined);

WHEREAS, pursuant to that certain Amended and Restated Security Agreement, dated as of March 12, 2004 (as may have been amended, modified, extended or restated from time to time), made by Vycom and Compression Polymers in favor of Wachovia Bank (the "Wachovia Security Agreement"), a security interest (the "Wachovia Security Interest") was granted, among others, in certain trademarks and trademark applications (the "Wachovia Trademarks"), including the Wachovia Trademark Collateral (as hereinafter defined);

WHEREAS, the First Union Security Interest granted by Vycom was recorded in the United States Patent and Trademark Office on April 16, 2001, at Reel 002279 and Frame 0790:

WHEREAS, the First Union Security Interest granted by Compression Polymers was recorded in the United States Patent and Trademark Office on April 16, 2001, at Reel 002279 and Frame 0811;

WHEREAS, the Wachovia Security Interest granted by Compression Polymers was recorded in the United States Patent and Trademark Office on April 8, 2004, at Reel 002825 and Frame 0731;

WHEREAS, the Wachovia Security Interest granted by Vycom was recorded in the United States Patent and Trademark Office on April 8, 2004, at Reel 002825 and Frame 0758; and

WHEREAS, the Administrative Agent now desires to terminate and release the entirety of its First Union Security Interest in the First Union Trademark Collateral and its Wachovia Security Interest in the Wachovia Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, including the satisfaction of all obligations, indebtedness and liabilities secured by the First Union Trademark Collateral pursuant to the First Union Security Agreement and the Wachovia Trademark Collateral pursuant to the Wachovia Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Administrative Agent hereby states as follows:

1. Definitions.


- (a) The term "<u>First Union Collateral</u>," as used herein, shall mean all of Vycom's and Compression Polymers' respective right, title and interest as of the date hereof in the First Union Trademarks (including those items listed on <u>Schedule A</u> hereto).
- (b) The term "<u>Wachovia Collateral</u>," as used herein, shall mean all of Vycom's and Compression Polymers' respective right, title and interest as of the date hereof in the Wachovia Trademarks (including those items listed on <u>Schedule B</u> hereto).
- 2. <u>Release of Security Interest</u>. The Administrative Agent hereby terminates, releases and discharges the entirety of its First Union Security Interest in the First Union Trademark Collateral and its Wachovia Security Interest in the Wachovia Trademark Collateral, and any right, title or interest the Administrative Agent may have in the First Union Trademark Collateral or the Wachovia Trademark Collateral shall hereby cease and become void.
- 3. <u>Further Assurances</u>. The Administrative Agent hereby agrees to duly execute, acknowledge and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.






